## Showcase Tickets Sales Begin May 1<sup>st</sup>

Tickets will go on sale on Monday, May 1. Ticket price is \$13 or \$16 (depending on seat location) plus any applicable box office or Ticketmaster fees. The Saenger box office charges a \$3 facility fee and a \$1 box office fee per ticket.

Ticketmaster fees vary depending on the options you select, but are typically higher than the box office fees.

You will be able to select your specific seats. Please remember that if you want your child to sit with you when not performing, they will have to have their own ticket. If you will need to get up frequently to change your child, we suggest that you select seats on the aisle and on the right side of the orchestra seating. This will give you easier backstage access and will be less disruptive to other patrons. Thank you for your consideration.
