

Dear LPA Families:

Tickets for “Once Upon a Dream” and “Sleeping Beauty” will go on sale on May 24, 2021. The Saenger has recently received approval from the City of Pensacola to increase capacity to 50%. We are aware that the Pensacola Bay Center will soon be open at 100% capacity, however, the Bay Center is under the authority of Escambia County and follows different regulations. We understand that this can be frustrating, but we are thankful to the Saenger for working with the City to expand capacity in time for our shows.

The Saenger’s COVID-compliant seating chart is divided into “pods” of 1, 2, 3, or 4 seats. For the first week of ticket sales each family is limited to purchasing 4 tickets for “Once Upon a Dream” and 5 tickets to “Sleeping Beauty,” this will allow all families an opportunity to purchase tickets to see their child dance. Please note that the difference in ticket limits is based on the number of students in each show. Please be considerate of all families, we all want to see our kids on stage. Beginning on June 1st, families will be allowed to purchase additional pods, if they wish. Please get your tickets early to ensure you get a seat.

Please note, you must purchase all tickets within a pod. The Saenger is not allowed to split up pods and sell them to different households. However, if you wish to share some of the tickets in your pod with another LPA family, that is not a problem. The tickets just need to be purchased together. If you end up with extra tickets or need extra tickets, Emily at the front desk can take your information and we can connect you with someone who wants to buy/sell tickets. **Disclaimer: If you choose to buy or sell extra tickets in a pod you understand that the seating within the pod is not socially distanced and that you are assuming any risk of sharing non-socially distanced space with members from another household.**

We are still exploring the option of live streaming both shows, however we would need to have sufficient interest to make this option economically feasible. If you think that this is a service that you would be interested in, please let the front desk know. Patrons would purchase an online streaming “ticket” that would be unique to them and allow that household to view the performance from home. We are also still taking orders for blu-ray’s for both shows.

Ticket sales are handled by the Saenger Box Office and Ticketmaster. Please remember that if you want your child to sit with you when not performing, they will have to have their own ticket and that this ticket will be part of your family’s allotment. We will have helpers backstage watching each class, so parents do not feel like they need to purchase a ticket for their child.

Ticket price is \$27 or \$30 (depending on seat location) plus any applicable box office or Ticketmaster fees. The Saenger box office charges a \$3 facility fee and a \$1 box office fee per ticket. Ticketmaster fees vary depending on the options you select but are typically higher than the box office fees. A child under the age of 2 does not need a ticket if they sit on a valid ticket holder’s lap.

The Saenger Box Office is located at 22 East Intendencia Street between the corners of Palafox and Jefferson Street. The Box Office’s temporary hours of operation are Monday through Friday, 10 am – 2:00 pm. Please check the Saenger website for the most updated information.
